## Channel Report

We are hopeful for a high water year. In any case we ask that you please remember to use caution when traveling between the lakes. Remember to use VHF channel 11 to announce channel passage. All traffic should move north at the top of the hour and south at the bottom of the hour. Please, no fishing in the channel. A work day is scheduled for the 25<sup>th</sup> of June. Please meet us at the channel at 10 am. Thank you!

## Community Complaints

This year there were numerous complaints regarding the increase of undesirable behavior to the area regarding hunting and fishing. The complaints were of folks herding and harassing caribou with snow machines, pursuing caribou with snow machines as they were fleeing, night hunting with artificial light, wounding and poaching of caribou and other small game, and the shooting from the road and lake towards structures and people.

Littering along the roadside and lake with toiletries, beer cans, water bottles and other miscellaneous waste was also mentioned. The LSTCA would like to hear from the community at our Annual Meeting on July 10th so we can offer suggestions to the State of Alaska, Department of Fish and Game, Division of Fish and Wildlife Troopers, State Troopers and the Matanuska Borough, for the inherent long-term safety of the Lake Louise and surrounding community and to conserve wildlife for future generations.

## Community Library



The idea of a community book exchange was brought up at the 2020 Annual Meeting. The LSTCA Board decided to sponsor a Community Book Exchange and Bari Gray (former board member) built and donated a book box. The box is located at the Paradise General Store at mile 16.5 Lake Louise Road for all community members to utilize. The goal is to share a love

of books as far and wide as possible. Our library box will function as a neighborhood book exchange. The idea is that someone will take a book which piques their interest, and sometime in the future return that book, or a totally different one.



## What has the LSTCA done for you?

- After receiving complaints about a filthy public restroom at the Mat-Su boat launch, the association reached out to the borough and was able to get them to clean it and maintain it in the future.
- The association published a brochure for visitors and residents to inform them on the lake system and available services. This brochure can be found at all businesses in the community.
- Gave a \$10,000 donation to the Wolf Pack Snow Machine Club to help maintain our community trails.
- Continues to maintain the channel signage and buoys for safety of all boaters.
- Maintains fire extinguishers, pumps and other equipment throughout the entire lake system, allowing a faster response to any fire in our community.
- Supplies satellite phones at 3 strategic locations around the lake system for emergency use.
- Maintains medical equipment such as Defibrillators, and first aid supplies at all community businesses.
- Sponsors projects like the book exchange, the causeway boat launch improvement project, and community cleanup day.

## Matthews Public Safety Building

The MatSu Borough has announced that the Matthews Public Safety building is scheduled to be demolished and removed this summer.

## **Bylaws Review and Revision**

The LSTCA formed a committee to update the LSTCA bylaws with the goal of presenting a final draft of the revised bylaws to the LSTCA membership at the Annual Meeting in July for discussion and adoption. The updates to the bylaws are being guided by the State of Alaska, Division of Community and Regional Affairs Handbook. The committee is soliciting input for consideration from the membership. ## **Lake Louise Road Resurfacing**

The State of Alaska Department of Transportation will be resurfacing the road from MP9 – MP19 this summer starting in late July. They will replace or upgrade 5 - 6 culverts, clean additional culverts, fill in a pond at MP 12.6, and level the road. The road will be reduced to one lane during the construction.

### **Alphabet Hills Prescribed Fire**

The Alaska Department of Fish & Game (ADF&G) continues to plan the Alphabet Hills prescribed fire. The burn window for the operation is between June 15 and September 30. The Division of Forestry and the Alaska Fire Service will be conducting the burn for the ADF&G. Access to the area will be restricted during and after the burn. Burn information will be

available on the Glennallen media outlets and at [www.akfireinfo.com](http://www.akfireinfo.com). Sue Rodman, the ADG&G employee planning the prescribed fire has been invited to the annual meeting. Sue will give an update on the plan and this will be a good opportunity for questions from community members.

### **Treasurer's Report:**

The LSTCA remains financially stable, due in large part to the funding provided through the MSB's Community Assistance Program and membership dues. Anticipated major expenditures in the upcoming quarter include insurance premiums for the association and volunteer fire department and tax preparation fees for the association's 2020 taxes.
